1. **THIS COURT ORDERS AND ADJUDGES** the Plaintiff be and is hereby authorized to continue to exclusively use the name of the Plaintiff Association, namely Telugu Cultural Association of Greater Toronto.
2. **THIS COURT ORDERS AND ADJUDGES** the Defendants and their successors, who have been elected as officers and/or members of the Executive Committee 2010 and Board of Trustees

2009-2011 of the defendants, shall cease using the name of the Plaintiff's Association Telugu Cultural Association of Greater Toronto, TCAGT, or any combination thereof deceptively similar or otherwise, for any of its activities including operating its website www.tcagt.com and any other websites with names similar or deceptively similar or otherwise to the name and website of the Plaintiff, after June 30, 2010.


3. **THIS COURT ORDERS AND ADJUDGES** the Defendants and their successors, their respective heirs, executors, administrators, or assigns shall stop using the website www.tcagt.com after June 30, 2010, and the Court notes the assertions of the Defendants and their successors that they do not have the authority to hand over the above website, www.tcagt.com to the Plaintiff as it is not owned and controlled by the Defendants and their successors.
4. **THIS COURT ORDERS AND ADJUDGES** the Defendants and their successors, their respective heirs, executors, administrators, or assigns shall not represent themselves in any way being associated with the Plaintiff's Association or TCAGT or any combination thereof deceptively similar or otherwise.
5. **THIS COURT ORDERS AND ADJUDGES** the Defendants and their successors, their respective heirs, executors, administrators, or assigns shall not use the intellectual properties of the Plaintiff, including but not limiting to literary works, dramatic, musical and artistic works developed by or for the Plaintiff.
6. **THIS COURT ORDERS AND ADJUDGES** that neither party herein shall speak or caused to be spoken, publish, or cause to be published, distribute or caused to be distributed any words or literature in any way disparaging or speaking ill of the other party, specially in regards to this settlement.

7. **THIS COURT ORDERS AND ADJUDGES** the parties herein shall keep their respective trust and membership funds in their possession as of May 30, 2010, and such funds may only be withdrawn by their respective signatories as of the date of the signing of the Agreement between the parties.
